TEACHERS, NURSES AND SCHOOL COUNSELORS IDENTIFY THE CHILDREN WHO ARE AT GREATEST RISK OF MISSING MEALS DURING WEEKENDS. THESE CHILDREN OFTEN HAVE LITTLE OR NOTHING TO EAT AT HOME, AND RETURN TO SCHOOL ON MONDAY HUNGRY, TIRED AND ILL-PREPARED TO LEARN.
